A Retired Squatter's House 21 Chester Street

In the 1881 census for 21 Chester Street Edinburgh the head of the household was stated to be Charles Sidey a retired squatter aged 58 years; a squatter in nineteenth-century Australia being a settler who occupied a large tract of Aboriginal land in order to graze livestock. The census listed as living with him at that time his wife Allison Isabella aged 47, three daughters, one son, six servants and a visitor and her lady's maid.

On 19 June 1863 Miss Mary Walker of Coates, residing at Drumsheugh, Mr Monro of Auchenbowie and builders Arthur Colville, John Muir and John Macgibbon had petitioned the Dean of Guild Court for permission to erect a line of houses with stables and offices behind the same upon the north side of Chester Street – stances 5, 9, 13, 17, Miss Walker having a dwelling house built on stance 11. A warrant for No 7 had already been granted. Mary, the last family owner of the Walker Estate, also intended to feu the remaining stances on the north side of Chester Street, namely 1, 3, 19 and 21 to others to build on. The Petition concluded In ignorance that any warrant was necessary for the Buildings but without the slightest intention of shewing disrespect to the Court the work has been commenced, but it is respectfully hoped that this advertency may be overlooked.

It was. The builders completed the work by 1870 and the Post Office Directory for 1871-2 lists Charles Sidey at 21 Chester Street. Previously the Sidey family consisting of parents, six daughters, three sons and seven servants had resided in 7 North Royal Circus which they probably rented.

Charles Sidey had been born in Perth, Scotland on 26 March 1823. His father Graham Sidey was born on 27 October 1796 in Methven and he died on 14 December 1880 in Perth. His mother Frances Monteith, born 6 April 1802 in Harperston Dunblane, died in 1837 in Perth. Like many Scots young Charles seems to have gone to the southern hemisphere to make his money. In Australia

he established himself in Barangaroo and Bowenfels New South Wales. He also, however, had business connections in New Zealand. A Charles Sidey merchant pioneer settler of Kaiapoi in the South Island bought land there in 1853 and established a hotel, wool store and general store. The ferry landing in Charles Street is called Sidey Quay. The first two Sidey children were born in New Zealand and later newspaper references described Charles as of Australia and New Zealand.

Charles Sidey married Allison Isabella Walker in 1854 at Wallerowang near Hartley New South Wales. Allison was the daughter of James Walker 1785-1856, born in Perth Scotland, son of a wealthy merchant. James retired as an Artillery Officer in the Royal Marines in 1822 and sailed to New South Wales in 1823. Allison's mother was Robina Ramsay Walker and Allison was born in Perth Scotland in 1834.

Frances Monteith Sidey married Colin Campbell on 7 June 1876 at 21 Chester Street. A daughter was born on 10 June 1877 and a son on 18 March 1879, both at 21 Chester Street.

Mary Allison Sidey married Captain H. B. Gundry March 1887 and Wilhelmina Walker Sidey married James Devonshire on 3 July 1889. James Walker Sidey married Charlotte Symes in 1895 while

Charles Lyon Sidey married Ethel Marley on 8 October 1895.

The Sidey family must have come to Edinburgh after the birth of George and before that of Margaret. After residing in North Royal Circus where the 1871 census recorded him Charles bought 21 Chester Street. Although retired he maintained his business interests being, for example, a Director of the Mortgage Company of South Australia Ltd, the British and America Estates Company Ltd (to assist persons to settle as farmers in the USA and British North America), the London Board of the Royal Bank of Queensland Ltd and the Mount Usher Gold Mines. He settled, however, into Edinburgh social life, joined the Society of Antiquaries in 1875 and became a Director of the Royal Hospital for Sick Children in 1876. He also maintained connections with Perth and St Andrews, being a member of the Royal Perth Golfing Society and attending St Andrews Royal and Ancient Golf Club Ball accompanied by Miss Sidey (Robina) and Miss Mary Sidey in September 1879.

The census of 1881 illustrates the type of wealthy middle class family living in Edinburgh at that time in a large establishment of five floors. In addition to their parents the children present on 3 April comprised daughters Robina aged 26, Mary aged 21, Marjory aged 11 and son George aged 13. Visiting them were Josephine Dobie born in London and her 54 years old lady's maid born in Tunbridge Wells. The birthplaces of the household servants show how Edinburgh attracted people to work in domestic service from all over Scotland. Cook Elizabeth Keillor, aged 26 came from Forfarshire but her assistant 20 years old Marjory hailed from Tallin. Jackie Stewart housemaid, born in Perthshire was aged 34 but the laundress Margaret Ross aged 29 came from Rosshire. The 20 years old footman Daniel Banks had been born in Glasgow. The only local household servant was assistant housemaid Catherine Petrie aged 25 but she gave Leith as her place of birth – not part of Edinburgh until 1920.

Something of the lifestyle of the Sidey family can be gauged from references to them in the local newspapers. These are listed below in chronological order.

The Post Office Directories for 21 Chester Street for 1886-7, 1887-8, 1888-9 and 1889-90 list Colonel Malcolm CBRE. However he must have leased the property from Sidey. Edward Donald Malcolm of Poltalloch 1837-1930 was a distinguished soldier and after retirement from the army he

became an administrator appointed to various government posts. Reports of his death and funeral appeared in the *Scotsman* of 21 and 25 March 1930. There are several references to him in that newspaper when he resided in 21 Chester Street.

There are no Post Office Directory entries for 1890-1 and 1891-2. 1892-3 lists Andrew Thomson to whom Charles Sidey sold the property.

Andrew Thomson was a timber merchant of Thomson, Mitchell and Co., 9 South St Andrew St and Granton Harbour, Telegraph 'Thomson', Telephones 12 Edinburgh, 802 Granton. Andrew Thomson died on 31 May 1893 leaving a personal estate of over £66,000. His wife Martha was born in 1843, the daughter of William Wilson of Bannockburn. She died on 22 October 1914. The Thomson family had been living in 15 Inverleith Place when recorded in both 1881 and 1891 censuses. In 1881 Andrew Thomson, a timber merchant born in Alloa was aged 43; his wife being 38. At that time their family consisted of:

Janet aged 8

Martha aged 5

William aged 3

Ernest aged 4 months.

By the 1891 census Alan (8) Evelyn (6) and Ruth (5) had been added to the list although Janet was missing. Two servants were recorded – Cook Helen Preston born in Borthwick and Alexa Campbell laundry maid from Invernesshire.

These included a mahogany dining table, mahogany three tier and circular dumb waiters, Chesterfield sofas, a cottage piano, a French cylinder front writing desk, mantel and carriage clocks, mirrors, Dresden candelabra and candlesticks, Oriental vases, iron French beds, Doulton jardinières and pedestals, furnishing of maids' rooms and kitchen, letter copying press, refrigerator, china dinner service, dessert, breakfast, tea and coffee ware, Turkey, Axminster and Brussels carpets and much else.

St Denis School occupied 21 Chester Street until 1932. There is a separate history under *Women of the West End*. On 12 June 1931 Janet Mitchell Thomson and Captain Evelyn Claude Ogilvie Thomson sold 21 Chester Street to Maybel Margarita Benvie Principal of St Denis for £2,600.

Evelyn Thomson survived the First World War. His brother did not.

Scotsman references to Alan Graham Thomson

13 October 1917 Reported missing Lt (Temp Capt) Royal Scots. Writer to the Signet, partner in firm of Mitchell and Baxer South Charlotte Street. He is a son of the late Mr Andrew Thomson 21 Chester Street and is married to a daughter of the late Mr Robert

Weir, an ex Master of the Edinburgh Merchant Company. Born in 1882 he was educated at Edinburgh Academy, being Dux of the school in 1900. He played in the school Rugby fifteen and the cricket eleven and won the mile and the steeplechase in 1900. On leaving the Academy he proceeded to Oxford where he graduated BA. He has been at the front for a year and hopes are entertained that he is a prisoner of war.

7 August 1918 Confirmed as killed on 26 September 1917. He obtained a commission in a Territorial Battalion of the Royal Scots in July 1915 and went to the front in October 1916. He fell in a gallant attempt to straighten the line held by his battalion, leading his company in a determined charge against a superior enemy force. He was 35 years of age.

25 May 1925 A marriage will shortly take place between Henry son of Henry Boddington JP Pownall Hall Wilmslow Cheshire and Alice daughter of the late Robert Weir Edinburgh and widow of Alan Graham Thomson WS Edinburgh.

Maybel Margarita Benvie

See *Women of the West End* for the occupancy of St Denis School.

In 1932 Maybel Benvie sold the property to James Black Cameron who argued that as there was no sale for properties of the size of 21 Chester Street, the house should be converted to flats.
